- 1. All details on this form must be accurately and entirely completed to allow the named child to be admitted on to camp. This includes the disclosure of all medical and other relevant details. Grand Star Hellenic will not be responsible for any form of medical consequence which may result from failure to disclose relevant information.
- 2. In the event your child is on medication, you consent to us administering the relevant medication (including, without limitation, epipens if applicable) without obtaining further permission. We also retain the right to administer over the counter medication, plasters and similar medical-related items for minor ailments. In the event that your child requires immediate medical treatment and we are unable to contact you, you authorise the Senior Management Team (SMT) to consent to emergency medical assistance/treatment on your behalf, which may include the use of anaesthetics.
- 3. Payment for camp must be made within the specified time and is not refundable or transferable.
- 4. The Camps Committee in conjunction with the SMT running camp, in their absolute discretion, have the right to send home any child for any anti-social or unruly behaviour, or for any conduct which the Camps Committee or SMT deem unacceptable. In such circumstances payment will not be refunded.
- 5. Grand Star Hellenic accepts no liability for any property lost, stolen or damaged, regardless of cause. Grand Star Hellenic accepts no liability for personal injury or the death of any participant unless caused by the negligence of Grand Star Hellenic.
- 6. Grand Star Hellenic accepts no responsibility for losses or additional expenses in the event of cancellation or change due to any event outside the control of Grand Star Hellenic (including without limitation strikes, disasters, war or the threat of war, acts of terrorism, weather or sickness).
- 7. Camp staff shall have the right to search every child and their possessions, at any time during the duration of camp for prohibited items.
